BE IT FURTHER RESOLVED, that the expenditure of \$152,850.00 from CIP 61-001.0, ANNUAL ALLOCATION - SUDDEN TRAFFIC CHANGES, fund 30300, is hereby authorized solely and exclusively for

providing funds for said project and related costs, and
