BE IT FURTHER RESOLVED, that the Council hereby accepts on behalf of The City of San Diego, the building restricted easement over, upon, or across all of Parcels 'A' and 'B', as provided for in Planned District Development Permit No. 83-0096, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said parcel map, as and for the act of the Council and that said Council has approved said parcel map; that the private street easement, together with the right of ingress and egress for the repair, maintenance, and alteration of any utility equipment or facility, and the right of ingress and egress of emergency vehicles, as well as the building restricted easement, all as granted and shown on the parcel map, are accepted on behalf of the public as heretofore stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said parcel map to the County Recorder of the County of San Diego, California.
