RESOLUTION NUMBER R-283412

ADOPTED ON FEBRUARY 22, 1994

WHEREAS, Deputy Mayor George Stevens has established a Fourth Council District Arts and Cultural Commission, pursuant to section 43(b) of the Charter of The City of San Diego, to plan the Second Annual Fourth Council District Arts and Cultural Festival; and

WHEREAS, the Commission was selected on March 24, 1993 to coordinate the plans for the Festival; and

WHEREAS, the Commission's goal is to foster an awareness, understanding and appreciation of the rich diverse ethno-specific arts and culture existing within the Fourth District; and

WHEREAS, to pay for the expense of the Second Annual Fourth Council District Arts and Cultural Festival, funds need to be raised, a budget needs to be approved and the City Manager may need to execute contracts for and on behalf of The City of San Diego, provided that limitation on expenditures be restricted to the amount of money received as donations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the provisions of Council Policy 100-2 are hereby waived to allow receipt of donations for the Second Annual Fourth Council District Arts and Cultural Festival on Saturday, April 9, 1994.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized to establish a special fund to record all revenues and expenditures of the event and thereafter deposit any


excess donations in the General Fund.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute all contracts necessary regarding the event, said contracts to be funded to the extent of monies donated and received by the Auditor and Comptroller.

BE IT FURTHER RESOLVED, that the City Council hereby approves the proposed budget (attached hereto as Attachment A) for the Second Annual Fourth Council District Arts and Cultural Festival to be held on Saturday, April 9, 1994.
