## RESOLUTION NUMBER R-283477 ADOPTED ON MARCH 1, 1994

WHEREAS, the Mt. Hope Rehabilitation Program (the "Program") was established by a joint action of the Council of The City of San Diego (the "Council") and the Redevelopment Agency of The City of San Diego (the "Agency") on July 11, 1991, by Council Resolution No. R-278056 and Agency Resolution No. 1980; and

WHEREAS, twenty-two thousand dollars (\$22,000) of Community Development Block Grant ("CDBG") funds was loaned to the Agency at that time for implementation of the Program; and

WHEREAS, the Mt. Hope Neighborhood Clean-up Program was an element of the Program; and

WHEREAS, by Agency Resolution No. 2284, adopted on September 14, 1993, the Agency executed an agreement with the Mt. Hope/Helix Heights Residents Association which authorized a two year clean-up program and the first year's funding for the clean-up program; and

WHEREAS, the second year's funding was subject to City Council appropriation of funds; and

WHEREAS, on March 1, 1994, the City Council voted to not fund the Mt. Hope Neighborhood Clean-up Program for a second year, as seventeen thousand dollars (\$17,000) still remained from the previous year's allocation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the second year of funding for the Mt. Hope Neighborhood Clean-up Program is not approved.
- 2. That the contract with the Mt. Hope/Helix Heights Residents Association be extended to allow the expenditure of seventeen thousand dollars (\$17,000) which remains from the monies previously allocated on September 14, 1993, pursuant to Agency Resolution No. 2284.
- 3. That the City Manager return to City Council with a recommendation for funding additional clean-up in adjacent neighborhood areas.
