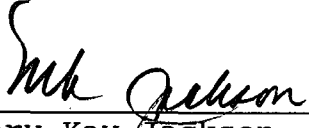

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$103,000 from CIP No. 29-646.0, Dailard Park Development, Capital Outlay Other Fund No. 302453, is hereby authorized, solely and exclusively to supplement the funding previously authorized by Resolution No. R-280499.
