BE IT RESOLVED, by the Council of The City of San Diego that the specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF TRAFFIC SIGNAL INTERCONNECT SYSTEMS ON IMPERIAL AVENUE FROM 47TH STREET TO LISBON STREET/69TH STREET, San Diego, California, on file in the Office of the City Clerk of San Diego, California on MAR 21 1994 and bearing official document No. W.O. 112159, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF TRAFFIC SIGNAL INTERCONNECT SYSTEMS ON IMPERIAL AVENUE FROM 47TH STREET TO LISBON STREET/69TH STREET.

BE IT FURTHER RESOLVED, that the expenditure of \$285,000.00 from CIP 68-008.0, ANNUAL ALLOCATION - TRAFFIC SIGNAL SUBSYSTEMS, TransNet Fund 30300, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to retain excess monies, if any, in CIP 68-008.0.
