## RESOLUTION NUMBER R- 283550 ADOPTED ON MAR 21 1994

WHEREAS, the City of San Diego is the recipient of a grant award titled "Safe Haven," a copy of which is on file in the Office of the City Clerk as Document Number RR-282032, which is jointly funded by the United States Departments of Justice, Education, and Housing and Urban Development, administered by Cities in Schools, Inc., and the purpose of which is to create a multi-service center accessible to residents in the Weed and Seed target area; and

WHEREAS, a Safe Haven Coordinator, Anthony Majadi, has been selected by a competitive process that satisfies Council Policy 300.7 and Administrative Regulations 2.2, 6.5, and 6.8, and the Weed and Seed Neighborhood Council and Executive Steering Committee wish to employ Anthony Majadi as Safe Haven Coordinator; and

WHEREAS, the salary of the Safe Haven Coordinator is funded entirely by Safe Haven grant funds, NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be and is hereby authorized and empowered, for and on behalf of the City of San Diego, to enter into an agreement with Anthony Majadi to provide services as Safe Haven Coordinator for the period of January 1, 1994, through October 31, 1994, contingent upon continuation/renewal and availability of grant funds through the agreement period.

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized to expend Safe Haven grant funds to execute this agreement, including any amendments or extensions thereof, and to certify that the City will comply with all applicable statutory or regulatory requirements related to said grant.

BE IT FURTHER RESOLVED, that any grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
