BE IT RESOLVED, by the Council of The City of San Diego that the specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for EXCAVATION PLANS FOR WEST MIRAMAR SOLID WASTE DISPOSAL FACILITY - PHASE II (MODULES 2/3), San Diego, California, on file in the Office of the City Clerk of San Diego, California on MAR 28 1994, and bearing official document No. W.O. 112458, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for EXCAVATION PLANS FOR WEST MIRAMAR SOLID WASTE DISPOSAL FACILITY - PHASE II (MODULES 2/3).

BE IT FURTHER RESOLVED, that the expenditure of \$3,600,000.00 from CIP No. 37-056.0, WEST MIRAMAR LANDFILL DISPOSAL FACILITY - PHASE II, Waste Management Enterprise Fund, Fund No. 41201, is hereby authorized solely and exclusively for

providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that stating for the record that the City of San Diego, as lead agency, has reviewed and considered the final environmental document, DEP File No. 80-09-31.
