## RESOLUTION NUMBER R-283678 APR 11 1994

WHEREAS, the City of San Diego is the recipient of a grant award titled "Operation Weed and Seed," which is funded and administered by the United States Department of Justice, and a copy of which is on file in the Office of the City Clerk as Document Number R-280081; and

WHEREAS, the Neighborhood Council and the Executive Steering Committee of Operation Weed and Seed have selected for subcontracting a program proposed by Palavra Tree, Inc., and titled, "Health, Environment, and Police Science Academy for Youth," the first and second phases of which were approved by City Manager action, a copy of which is on file in the Office of the City Clerk as Document No. C-05094; and

WHEREAS, the Neighborhood Council and the Executive Steering Committee now wish to extend and augment the original agreement to include phase three of the program, which action will raise the agreement total to over twenty-five thousand dollars (\$25,000.00); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be and is hereby authorized and empowered, for and on behalf of the City of San Diego, to enter into an agreement with Palavra Tree, Inc., to provide phase three of the original "Health, Environment, and Police Science Academy for Youth" program through April 30, 1994, contingent upon extension of the agreement period;

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized to expend Operation Weed and Seed grant funds to execute this agreement, including any amendments or extensions thereof, and to certify that the City will comply with all applicable statutory or regulatory requirements related to said grant.

BE IT FURTHER RESOLVED, that any grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
