BE IT FURTHER RESOLVED, that the City Manager be and he is hereby directed to continue to pursue \$1,200,000 in Federal funding to reimburse the City for its expenses on the truck route facility, and to pursue another \$1,000,000 to upgrade to a permanent facility.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$1,200,000 from CIP No. 52-347.0 (Division Street from Interstate 5 to 43rd Street) to CIP No. 52-589.0 (Otay Mesa Truck Route) of TransNet financing.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to

exceed \$50,000 from CIP No. 52-521.0 (City Assisted Local Street Improvements) to CIP No. 52-589.0 (Otay Mesa Truck Route) of TransNet financing.
