BE IT RESOLVED, by the Council of The City of San Diego that the specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF BROADWAY TILE REPLACEMENT, San Diego, California, on file in the Office of the City Clerk of San Diego, California on MAY 02 1994, and bearing official document No. W.O. 112301, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF BROADWAY TILE REPLACEMENT.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$403,600.00 from CIP 52-325.0, BROADWAY BUS ACCOMMODATION PLAN, TransNet Fund 30300, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, in CIP 52-325.0.
