\$150,000 from Fiscal Year 1994 appropriations \$432,564 from Fiscal Year 1995 appropriations, contingent on Council approval of funds for this purpose in the Fiscal Year 1995 CIP budget. BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
