

RESOLUTION NUMBER R- 283907

ADOPTED ON MAY 16 1994

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with BSI Consultants, Inc. for professional design services in connection with the Miramar Storage Tank/Reclaimed Water Connection - Reclaimed Water Distribution System, under terms and conditions set forth in the Agreement, a copy of which is on file in the office of the City Clerk as Document Number RR- 283907, as well as any reasonably necessary modifications or amendments thereto which do not increase this project's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$582,564 from Water Revenue Fund 41500, CIP No. 70-917.0, Miramar Storage Tank/Reclaimed Water Connection - Reclaimed Water Distribution System, is hereby authorized, solely and exclusively to provide funds for the above agreement, to be expended in the following manner:

\$150,000 from Fiscal Year 1994 appropriations

\$432,564 from Fiscal Year 1995 appropriations, contingent on Council approval of funds for this purpose in the Fiscal Year 1995 CIP budget.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.


