A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO RATIFYING THE ELECTION RESULTS OF MARCH 15, 1994, FOR THE CITY HEIGHTS REDEVELOPMENT PROJECT AREA COMMITTEE.

WHEREAS, the Council of The City of San Diego (the "Council") adopted the City Heights Redevelopment Project; and

WHEREAS, the bylaws of the City Heights Redevelopment Project Area Committee (the "PAC") call for an annual election to be held in March to fill any vacancies and subsequent ratification by the Council; and

WHEREAS, four PAC members' terms expired and an election to fill the vacancies was held on March 15, 1994, according to the procedures enumerated in the bylaws; and

WHEREAS, the newly elected members of the Project Area Committee have submitted to this Council information establishing the qualifications of each person relative to category of membership and residence; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

**SUBJECT:** Ratification of City Heights Project Area Committee election.

**CITY HEIGHTS REDEVELOPMENT PROJECT**

In accordance with the City Heights PAC Bylaws, an election was held March 15, 1994, to fill vacant seats among the four categories of the PAC. As a result of the election, five members were elected. The names and categories represented by the five elected members nominated for ratification by the City Council are as follows:

**Residential Owner-Occupant:** Wayne English.

**Residential Tenant:** Allan Marshall and Robert E. Bolden.

**Business/Property Owner:** None.

**Community Organization Representative:** Richard Kacmar and  
Thomas E. Gibson.

Following the council's ratification of the election results of March 15, 1994, six (6) vacant seats will remain on the PAC.

The Mid-City Development Corporation staff, in concert with the City Heights Project Area Committee, will undertake efforts to fill the remaining vacancies through additional community outreach and future elections.
