283993, as well as any reasonably necessary modifications or amendments thereto which do not increase this project's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that expenditure of an amount not to exceed \$2,315,200 from CIP 21-834.0, Balboa Park/Mission Bay Park Requirements, is hereby authorized, solely and exclusively to fund this agreement, to be expended in the following manner:

\$ 576,800 from Fiscal Year 1994 appropriations; and

\$1,738,400 from Fiscal Year 1995 and other fiscal year appropriations, contingent upon Council appropriation of funds for this purpose in the fiscal year CIP budget.
