BE IT FURTHER RESOLVED, that the expenditure of \$2,761,000.00 from CIP 52-513.0, CROSBY STREET - HARBOR DRIVE TO I-5, \$1,261,000.00 from TransNet Fund 30300, \$1,290,000.00 from EDA, and \$210,000.00 from State and Local Partnership, is hereby authorized solely and exclusively for providing funds for said

project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to accept and execute the Federal Grand (EDA) in the amount of \$1,290,000.00 for CROSBY STREET - HARBOR DRIVE TO I-5, CIP 52-513.
