ADOPTED ON JUN 08 1994

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Camp, Dresser & McKee, Inc., for professional design services in connection with the Miramar Road Extension - Reclaimed Water Distribution System, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document Number RR-284030, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$616,000 from Water Revenue Fund 41500, CIP No. 70-916.0, Miramar Road Extension - Reclaimed Water Distribution System, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project, to be expended in the following manner:


\$150,000 from Fiscal Year 1994 appropriations;
and

\$466,000 from Fiscal Year 1995 appropriations,
contingent upon Council approval of funds for
this purpose in the Fiscal Year 1995 CIP budget.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
