BE IT RESOLVED, by the Council of The City of San Diego that the low bid of HAWTHORNE MACHINERY CO. (San Diego, CA), meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for LEASE WITH OPTION TO PURCHASE ONE GROVE HYDRAULIC CRANE WITH HYACINTH HARVESTING ATTACHMENT, as follows:

- 1. Extending the lease for an additional Six (6) months, from approximately May 1, 1994 through October 31, 1994; (original lease did not begin until approximately November 1, 1993 through April 30, 1994).
- 2. Increasing the monthly lease cost for the Six (6) month extension from the original cost of \$6,000.00 per month plus tax to \$7,560.00 per month plus tax.
- 3. Increasing the original purchase price from \$184,366.00 plus tax to \$219,850.00 plus tax, due to the addition of air conditioning at a cost of \$15,000.00 and specially designed crane outrigger stabilizers with 50% outrigger extensions at a cost of \$20,484.00; total cost for Six (6) month lease

extension is \$45,360.00; terms net 30 days plus sales tax; with option to purchase at end of lease period at a cost of \$219,850.00 plus sales tax, with 100% of lease payments to apply toward purchase price less interest to be charged at Bank of America prime rate plus 3% from date of delivery.

BE IT FURTHER RESOLVED, that the expenditure, is not to exceed \$48,535.20 from Fund No. 41500, Department No. 700, Organization No. 506, Object Account No. 4222, and Job Order No. 31455, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
