- 1. Eighty thousand dollars (\$80,000) from Fiscal Year 1994 appropriations.
- 2. Four hundred thirty-five thousand seven hundred fifteen dollars (\$435,715) from Fiscal Year 1995 appropriations contingent upon City Council approval of funds for this purpose in the Fiscal Year 1995 CIP Budget.
