A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ACCEPTING A LOAN REPAYMENT OF \$40,000 FROM THE LINDA VISTA REDEVELOPMENT PROJECT, AMENDING THE FY 1995 BUDGET OF THE CONTRIBUTION TO THE REDEVELOPMENT AGENCY FUND TO INCLUDE \$40,000 AND AUTHORIZING THE RELOAN OF \$40,000 TO THE COLLEGE GROVE REDEVELOPMENT PROJECT.

BE IT RESOLVED, by the Council of The City of San Diego (the "City"), as follows:

- 1. That up to \$40,000 from the Redevelopment Agency Fund 98501 be accepted, as cash becomes available, representing payment of interest on loans made by the City to the Redevelopment Agency of The City of San Diego (the "Agency") in the Linda Vista Shopping Center Redevelopment Project.
- 2. That the City Auditor and Comptroller be, and he is hereby authorized and directed to deposit and appropriate the above-recited \$40,000 to Fund 10227, entitled "Contribution to the Redevelopment Agency."
- 3. That the FY 1995 budget for Fund 10227, "Contribution to the Redevelopment Agency," be amended to include the above recited \$40,000.
- 4. That the Auditor and Comptroller be, and he is further authorized and directed to disburse the above-recited \$40,000 from Fund 10227 to the Agency for the purpose of paying necessary administrative expenditures for the College Grove Shopping Center Redevelopment Project, Fund 98001, Department 9802.

- 5. That the City Manager be, and he is hereby directed to record the above disbursement to the Agency as an interest bearing loan to be repaid as soon as practicable from tax increment or other revenues.
- 6. That in the event the Agency issues bonds, notes, refunding bonds or other instruments of indebtedness of the Agency to carry out these redevelopment projects, then any indebtedness of the Agency to the City, including any interest accrued thereon, shall be deemed not to be a first pledge of tax increment allocation received by the Agency pursuant to Health and Safety Code section 33670; and any indebtedness of the Agency to the City, including any interest accrued thereon shall be subordinate to any pledge of tax increments to bondholders or the holders of other such instruments of indebtedness.
