RESOLUTION NUMBER R-284127 ADOPTED ON JUNE 21, 1994

WHEREAS, the Council by Resolution No. 281140, adopted on November 23, 1992, certified the findings of No Significant Impact/Environmental Assessment DEP No. 89-1144, in connection with the approval of the Agreement For Phase II Aggregate Extraction West Miramar Landfill (Document No. RR-281140-1) between the City of San Diego and a Joint Venture of Superior Ready Mix Concrete, L.P., and West Coast General Corporation; and

WHEREAS, said Agreement authorized the construction and operation of a ready mix concrete batch plant, an asphaltic concrete plant and a cement treated base plant; and

WHEREAS, said Agreement required the operator to obtain all necessary permits for the ready mix concrete batch plant, an asphaltic concrete plant and a cement treated base plant; and

WHEREAS, San Diego Municipal Code section 101.0510 requires a Conditional Use Permit for a ready mix concrete batch plant, an asphaltic concrete plant and a cement treated base plant; and

WHEREAS, on February 3, 1994, Superior Ready Mix Concrete, L.P. submitted an application to the Planning Department for a Conditional Use Permit for the West Miramar Landfill; and

WHEREAS, it was determined that the Conditional Use Permit did not propose any activity not evaluated according to CEQA at the time the Agreement was reviewed; and

WHEREAS, the permit application was set for a public hearing to be conducted by the Council of The City of San Diego; and

WHEREAS, the issue was heard by the Council on June 21, 1994; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the information contained in the final document, DEP No. 89-1144, including any comments received during the public review process, has been previously reviewed and certified by this Council in connection with Resolution No. R-281140.
