BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$52,252.82, made payable to PEDUS SERVICE, to cover payroll processing fees and to effect payments in settlement of claims against The City of San Diego and Pedus Service by the ten former employees of CPAC.

BE IT FURTHER RESOLVED, that said funds are to be payable from Fund No. 81140, Public Liability Reserve Fund.
