## HOPWA PROGRAM ABSTRACT

Introduction and Approach. Housing Opportunities for People with AIDS (HOPWA) will be implemented by the City of San Diego Housing Commission in accordance with an HIV Housing Plan which has been developed by consumers and service providers.

Housing and Supportive Services. HOPWA funds, in the amount of \$1.847 million, will be used for housing projects, programs, and services described below:

- 1) Acquisition and Rehabilitation \$714,000 HOPWA funding will assist nonprofit housing developers to develop permanent affordable housing for people with AIDS/HIV. These funds will be used to leverage other housing dollars at a minimum ratio of 1 to 1.
- 2) Community Residences \$349,000
  This funding will support residential AIDS shelters and other congregate housing for people with AIDS/HIV. Approximately 80% of this funding will provide operating support or used start-up costs for new community residences; the remainder will be used for a shared housing/roommate matching program.
- 3) Rental Assistance \$465,000
  This funding will be used to provide tenant-based rental assistance for persons with AIDS/HIV, modeled after the Section 8 certificate program. Approximately 80 persons will be receiving rental assistance, at least 25% of whom also are being treated for TB.
- 4) Supportive Services \$ 18,000 This funding will be used to provide support staff for the Shelter Plus Care program.
- 5) Housing Information and Referral \$51,000 This funding will be used to provide a single-point of information for all HIV housing programs and services, including roommate matching.
- 6) Emergency Housing \$203,000 This funding will be used to provide temporary housing in housing in shelters or hotel/motel rooms for up to 30 days, or to provide a one-time mortgage or rental payment for persons with AIDS/HIV.
- 7) Contingency Funds \$47,000
  These funds will be used for emergency response to housing needs or to supplement funding of the activities listed above.

Administration. Ten percent, or \$205,000 will be used for program administration.
