BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to encumber an amount not to exceed \$790,498 for the City-wide Fire, Property and Earthquake insurance premium for a one-year period beginning June 15, 1994 through June 15, 1995.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$790,498, is hereby authorized, solely and

exclusively for the purpose of providing funds for the purchase of said insurance.
