BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF WATER MAIN REPLACEMENT GROUP 488.

BE IT FURTHER RESOLVED, that the expenditure of \$2,090,230.00 from Water Revenue Fund 41500, CIP No. 73-083.0, ANNUAL ALLOCATION FOR WATER MAIN REPLACEMENT, is hereby authorized solely and exclusively for providing funds for said project and related costs.
