RESOLUTION NUMBER R- 284314 ADOPTED ON JUL 25 1994

A RESOLUTION OF THE CITY OF SAN DIEGO REGARDING THE ACCEPTANCE OF FUNDS FOR A RECYCLING MARKET DEVELOPMENT ZONE.

WHEREAS, the development of recycling industries and recycled product manufacturers in the City of San Diego will make recycling efforts by businesses and citizens more convenient and cost-effective; and

WHEREAS, the City of San Diego and the County of San Diego are cooperating in their recycling market development efforts through the operation of the San Diego Recycling Market Development Zone in the Otay Mesa industrial community; and

WHEREAS, Assembly Bill 1220 authorized the California
Integrated Waste Management Board ("CIWMB") to issue a Request
for Proposals to provide up to \$25,000 in funds for each
Recycling Market Development Zone to further promote the zones
and to improve local assistance; and

WHEREAS, the City of San Diego, by its Environmental Services Director, applied to the CIWMB for a contract in the amount of \$24,470 for additional marketing and database development for the San Diego Recycling Market Development Zone; and

WHEREAS, the CIWMB has determined that the City's proposal merits funding; and

WHEREAS, procedures established by the CIWMB require the City to enter into an agreement with the CIWMB to implement the

project and to comply with certain assurances; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Environmental Services Director, or designee, be and is hereby authorized and empowered, for and on behalf of the City, to enter into an agreement with the California Integrated Waste Management Board to promote the San Diego Recycling Market Development Zone through development of marketing and promotional materials and to develop a recycling market development database, under the terms and conditions set forth in the Standard Agreement with said organization, a copy of which is on file in the office of the City Clerk as Document No. RR- 284314 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$24,470 from Waste Management Enterprise Fund 41200 is hereby authorized, solely and exclusively for the purpose of providing funds for the above projects, with said amount to be reimbursed by the California Integrated Waste Management Board.
