
RESOLUTION NUMBER R- **284329**

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to execute, for and on behalf of The City of San Diego, an agreement (with attached note and deed of trust) with the VIETNAMESE FEDERATION OF SAN DIEGO, a California corporation, making available to the Federation an amount not to exceed \$200,000 in CDBG funds, for the acquisition of real property located at 7833 Linda Vista Road, to be used as a refugee center providing social services to aid in the assimilation of refugees into San Diego, and into American society, under the terms and conditions set forth in that agreement on file in the office of the City Clerk as Document No. RR- **284329**.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$200,000 from CDBG Fund 18529, Vietnamese Federation - United Refugee Center, for acquisition of property rights and related costs, is hereby authorized and approved.
