WHEREAS, the Council of The City of San Diego (the "City") has previously given its general approval to financing plans for the Southcrest Redevelopment Project Area of the Redevelopment Agency of The City of San Diego (the "Agency"); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That it hereby accepts two hundred fifty thousand dollars (\$250,000) in land sales proceeds from the Mt. Hope Redevelopment Project as repayment on an interest bearing loan made to the Agency from the City.
- 2. That it hereby authorizes a transfer of two hundred fifty thousand dollars (\$250,000) as an interest bearing loan from Capital Outlay Other, Fund #302453, to CIP #39-501.0, 252 Corridor Acquisition/National City Mitigation, Fund #98334.
- 3. That the Auditor and Comptroller is hereby directed to record the transfer of two hundred fifty thousand dollars (\$250,000) to the Agency, as an interest bearing loan, to be repaid as practicable from tax increment or the appropriate revenues.
- 4. That the expenditure of an amount not to exceed \$250,000 from CIP #39-501.0, 252 Corridor Acquisition/National

City Mitigation, Fund #302453, is hereby authorized, solely and exclusively, for the purpose of providing funds for the National City Mitigation payment.
