



BE IT RESOLVED, by the Council of The City of San Diego, that the bid of Westinghouse Electric Corporation, the lowest responsible bidder, meeting the plans and specifications for implementation of the Metropolitan Wastewater Department operations management network (COMNET), is hereby accepted, and the City Manager is hereby authorized to execute the services contract therefor in an amount not to exceed \$14,778,905 in accordance with the form on file in the Office of the City Clerk as Document No. RR-284490.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$387,750 within the Clean Water Sewer Fund No. 41509, from CIP 42-910.1, North City Water Reclamation Plant, to CIP 45-920.0, Wastewater Operations Management Network.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$14,778,905 from the Clean Water Sewer Fund No. 41509, CIP 45-920.0, Wastewater Operations Management Network, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project, to be expended as follows:

\$2,486,925 for the first phase of this contract and COMNET related administrative costs

\$1,761,510 for the second phase of this contract, from Fiscal Year 1995 appropriations, contingent on Council appropriation of funds for this purpose in the FY 1995 CIP budget

\$2,739,450 for the third phase of this contract, from Fiscal Year 1996 appropriations, contingent on Council appropriation of funds for this purpose in the FY-1996 CIP budget

\$2,691,650 for the fourth phase of this contract, from Fiscal Year 1996 appropriations, contingent on Council appropriation of funds for this purpose in the FY 1996 CIP budget

\$3,120,060 for the fifth phase of this contract, from Fiscal Year 1997 appropriations, contingent on Council appropriation of funds for this purpose in the FY 1997 CIP budget

\$1,140,560 for the sixth phase of this contract, from Fiscal Year 1997 appropriations, contingent on Council appropriation of funds for this purpose in the FY 1997 CIP budget

\$ 838,750 for the seventh phase of this contract, from Fiscal Year 1998 appropriations, contingent on Council appropriation of funds for this purpose in the FY 1998 CIP budget

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this contract with tax exempt securities, if circumstances so warrant.
