WHEREAS, the City Manager is presently negotiating with the Hunter Corporation a proposed Change Order No. 2 to provide compensation for said additional requested improvements, and has recommended at this time that the Council approve additional funding for said purpose in an amount not to exceed \$380,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to negotiate and execute Change Order No. 2, with the Hunter Corporation in an amount not to exceed \$380,000 for the installation of a conveyor and hopper system, and to append said change order to that contract previously authorized by Resolution No. R-282916.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$380,000 from contingencies previously authorized

in Fund No. 41508, CIP No. 46-119.0, as authorized by Resolution No. R-282916, is hereby authorized, solely and exclusively for the purpose of funding this change order.
