BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for REPLACEMENT AND UPGRADE OF CENTRE CITY TRAFFIC SIGNAL SYSTEM (PHASE II) FROM BROADWAY TO G STREET AND FROM INDIA STREET - TO THIRD AVENUE AND THE INTERSECTION OF 4TH AVENUE AND C STREET.

BE IT FURTHER RESOLVED, that the expenditure, of \$295,250.00 from CIP 68-011.0, ANNUAL ALLOCATION- MODERNIZE TOP 5-10 PRIORITIZED TRAFFIC SIGNALS, Fund 30300, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to retain excess funds, if any, in CIP 68-011.0.
