BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION NESTOR COMMUNITY SIDEWALKS.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to Modify the FY '94 Capital Improvements Program Budget by adding CIP 52-618.0, NESTOR COMMUNITY SIDEWALKS.

BE IT FURTHER RESOLVED, that the expenditure of \$100,000.00 from CIP 52-618.0, NESTOR COMMUNITY SIDEWALKS, Fund 18529, Community Development Block Grant, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to retain excess budgeted funds, if any, in the project until completion.
