BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with NBS/Lowry Corp. for as-needed construction management and inspection services for the Water Utilities Department, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 284572, as well as any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$240,000, consisting of \$120,000 from Fund No. 41506, CIP 46-174.0, Annual Allocation - As-Need Consultant Services/Sewer, and \$120,000 from Fund No. 41500, CIP 73-312.0, Annual Allocation - As-Needed Consultant Services/Water, is hereby authorized, solely and exclusively to provide funds for the above project.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this agreement with tax exempt securities, if circumstances so warrant.
