

RESOLUTION NUMBER R- 284631

ADOPTED ON SEP 19 1994

WHEREAS, the Council of The City of San Diego is required by California Vehicle Code section 40203.5(a) to establish a Parking Citation Fine Schedule; and

WHEREAS, since the City's existing schedule was adopted in August 1993, there have been legislative actions impacting three violations: (1) the annual appropriation ordinance for Fiscal Year 1995, adopted as Ordinance No. O-18089 (N.S.), directed the City Manager to decrease the fine amount for Expired Meter violations from \$30.00 to \$25.00 -- which would result in an anticipated \$500,000 decrease in revenue; (2) the Municipal Code designation regulating parking in undesignated spaces in City parks was changed from Section 63.02.12 to Section 63.0102(b)(21) -- which would have no fiscal impact; and (3) in California Vehicle Code section 5204 - Current Registration Not Displayed, the county surcharge assessment was deleted, reducing fine amount from \$30.00 to \$25.00 -- no anticipated reduction in revenue since the surcharge went to the County Courthouse Construction fund; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Parking Violation Fine Schedule for Fiscal Year 1995, as attached hereto and on file in the office of the City Clerk as Document No. RR- 284631 , is hereby adopted.
