## RESOLUTION NUMBER R-

ADOPTED ON SEP 19 1994

WHEREAS, as a result of negotiations between the City
Manager and representatives of the various employee
organizations, a Health Insurance Premium Reimbursement Benefit
for Eligible Pre-1980 Retirees for Fiscal Year 1995 was
established; and

WHEREAS, the benefit established is a reimbursement of up to \$589.20 for Fiscal Year 1995 for actual health insurance premium expense incurred; and

WHEREAS, the benefit is effective from July 1, 1994 through June 30, 1995 only; and

WHEREAS, eligible retirees may apply the benefit toward reimbursement of the Medicare Part B premium, or request reimbursement of actual premium expense incurred for either a privately secured health insurance plan or one of the City-sponsored group health insurance plans or a combination thereof, the total benefit not to exceed \$589.20 per Fiscal Year 1995; and

WHEREAS, if the retiree should die prior to distribution of the annual reimbursement benefit, the named beneficiary will receive a pro-rata benefit based on the retiree's date of death; and

WHEREAS, it is estimated that the benefit will cost approximately \$800,000 and will be paid from the Retiree Health Insurance Trust Fund; and

WHEREAS, the City Manager has delegated the administration of the Fiscal Year 1995 reimbursement benefit to the Retirement Administrator for the City Employees' Retirement System; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered, for and on behalf of said City, to implement and carry out the purposes and intent of this program.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to expend an amount not to exceed \$800,000 from Fund 60013, solely and exclusively for the purpose of providing funds for the above program.

BE IT FURTHER RESOLVED, that the Retirement Administrator is hereby authorized to administer the said program.
