WHEREAS, there is no present or prospective use for the street either for the public street system, or which the right-of-way was originally acquired, or for any other public use of a like nature that can be anticipated in that the right-of-way is not needed for public street, bikeway, or open space purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That "F" Street, between 34th Street and Sunrise Street, as more particularly shown on Drawing No. 18152-B on file in the office of the City Clerk as Document No. RR-284655-1, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.
- 2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.






