BE IT FURTHER RESOLVED, that the expenditure of \$195,385.00 from CIP No. 29-704.0, TORREY PINES GOLF COURSE - IRRIGATION SYSTEM AND CART PATHS / PHASE II - NORTH, Golf Course Enterprise Fund No. 41402, is hereby authorized solely and exclusively for

providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
