

RESOLUTION NUMBER R- 284799ADOPTED ON OCT 31 1994

BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bids of MIRAMAR FORD TRUCK SALES, INC (San Diego, CA) and PACIFIC FREIGHTLINER TRUCKS (Lakeside, CA) meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of SIXTEEN (16) TRUCK TRACTORS as follows:

MIRAMAR FORD TRUCK SALES, INC (San Diego, CA) for Item 1 at a cost of \$484,570.90; terms net 30 days, including tax, with an option to purchase additional vehicles at the same price within six (6) months.

PACIFIC FREIGHTLINER TRUCKS (Lakeside, CA) for Item 2 at a cost of \$376,452.75; terms net 30 days, including tax, with an option to purchase additional vehicles at the same price within four (4) months.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$861,023.65 from Fund No. 50031, Department No. 8201, Object Account No. 6013, and Job Order Nos. 88095 and 88085, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
