BE IT FURTHER RESOLVED, that the expenditure in CIP 21-834.0, BALBOA PARK/MISSION BAY PARK REQUIREMENTS, sublet project 21-838.1, MUNICIPAL GYMNASIUM REAR STAIRWAY REPLACEMENT of \$105,340.00 from Transient Occupancy Tax Fund 102242, is hereby authorized solely and exclusively for providing funds for said project and related costs.
