BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets are accepted on behalf of the public as heretofore stated; that the easements with the right of ingress and egress for the construction and maintenance of sewer, water, and drainage facilities, as well as the landscaping easement, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
