WHEREAS, health insurance coverage is provided to eligible retirees by The City of San Diego through the Retirement System; and

WHEREAS, retirees have several options available to them in regard to providers of health coverage; and

WHEREAS, the Retirement Administrator recommended and the Retirement Board selected Secure Horizons/Pacificare to provide those services to eligible retirees; and

WHEREAS, the premiums for Secure Horizons/Pacificare are paid from the Retiree Health Insurance Trust Fund (60013); and

WHEREAS, this health insurance contract is somewhat unique in that it is administered by the Retirement System and not the Risk Management Department; and

WHEREAS, the City of San Diego has reviewed and approved the increase in the Secure/Horizons/Pacificare premium rates for the plan year from August 1, 1994 through July 31, 1995; and

WHEREAS, it is now necessary and appropriate to authorize the execution of the third amendment to the agreement for health insurance coverage to reflect the 1994-1995 plan year premium rates; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the President of the Board of Administration for the San Diego City Employees' Retirement System be and is hereby authorized and empowered to execute, a third amendment to the

agreement with SECURE HORIZONS, PACIFICARE OF CALIFORNIA, a federally qualified Health Maintenance Organization, to implement the premium rates as set forth for health care for eligible retirees pursuant to the terms and conditions of the Medical and Hospital Group Subscriber Agreement, a copy of which is on file in the office of the City Clerk as Document No. RR-

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$52,000 from Fund 60013, Account 96910, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above third amendment to agreement.
