BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF SAFETY ALL-WEATHER WALKWAYS VARIOUS LOCATIONS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$180,000.00 from CIP 52-327.0, ANNUAL ALLOCATION - SAFETY ALL-WEATHER WALKWAYS (TransNet Fund 30300), is hereby authorized solely and exclusively for providing funds for said project and

related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to retain excess budgeted funds, if any, in the project.
