BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$125,000.00, from CIP 12-069.0, GOLFCREST DRIVE AND RUANE STREET DRAIN (TransNet Fund 30300), is hereby authorized solely and exclusively for providing funds for said project and related

costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to retain excess budgeted funds, if any, in the project.
