BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bid meeting specifications, of ED GOMEZ & SON LANDSCAPE COMPANY, (San Diego, CA), is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE LANDSCAPE MAINTENANCE OF RANCHO BERNARDO COMMUNITY PARK as may be required for a period of one (1) year beginning November 1, 1994 through October 31, 1995, per prices on file in the Purchasing Division, for a total estimated annual cost of \$49,580.08, cash discount payment terms of 1/2% - 20 days, with options to renew contract for four (4) additional one (1) year periods with first year increases not to exceed 10% of the original contract prices and subsequent option year increases not to exceed 15% of the prices in effect in each prior period.

BE IT FURTHER RESOLVED, in the event the Contractor does not perform to specifications, the Purchasing Agent is hereby authorized to terminate the contract and award to the next low responsive and responsible bidder and to subsequent bidders, if necessary, until a bidder is found who performs to specifications.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$33,053.39 for FY95, from Fund No. 100, Department No. 444, Organization No. 720, and Job Order No. 007215, and \$16,268.79 contingent upon FY96 funding, is hereby authorized solely and exclusively for providing funds for said contract, and the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
