BE IT FURTHER RESOLVED, that the expenditure of \$120,400.00 from Transient Occupancy Tax Fund 102242, CIP No. 21-834.0, BALBOA PARK/MISSION BAY PARK REQUIREMENTS, sublet project No. 21-835.4, House of Hospitality and Persian Fountain, is hereby authorized solely and exclusively for providing funds for said

project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
