In the event an agreement is not entered into within 180 days following adoption of this resolution, then this resolution shall become void and be of no further force or effect.

That the City Clerk shall hereby cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
