AN ORDINANCE CALLING A GENERAL MUNICIPAL ELECTION IN THE CITY OF SAN DIEGO ON TUESDAY, NOVEMBER 7, 1995.

WHEREAS, in accordance with paragraph (d) of San Diego City Charter section 12, as amended by the voters on November 3, 1992, Councilmembers for Districts 2, 4, 6 and 8 shall be chosen by the electors at the Municipal Primary and General Elections in 1995 for a term of three (3) years; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. It is hereby ordered that a General Municipal Election will be held in The City of San Diego on Tuesday,

November 7, 1995, for the purpose of electing candidates for the following offices, unless such candidates have been elected in the Municipal Primary Election:

COUNCILMEMBER for District No. 2 three-year term

COUNCILMEMBER for District No. 4 three-year term

COUNCILMEMBER for District No. 6 three-year term

COUNCILMEMBER for District No. 8 three-year term

Section 2. For the purpose of said election, the election precincts shall be the precincts established by the Board of Supervisors of the County of San Diego; provided, however, that

certain said precincts shall be consolidated in the manner indicated on the list of consolidated precincts on file in the office of the City Clerk.

Section 3. The City Clerk shall designate the polling places, and shall appoint the members of the precinct boards for said election.

Section 4. The polls for said election shall be open from 7 a.m. until 8 p.m. on Tuesday, November 7, 1995.

Section 5. The City Clerk is hereby directed to procure and supply the required number of ballots, sample ballots, equipment, supplies and other printed matter.

Section 6. The following rates of compensation are hereby established for said election:

Inspectors	\$50.00*			
Clerks	\$35.00			
Rental of Polling Place	\$25.00			

^{*}Compensation provides for ballot box returns.

Section 7. By Resolution No. 285928, adopted June 12, 1995, the County Registrar of Voters was asked to provide specified services in connection with this election.

Section 8. The City Auditor and Comptroller is authorized and directed to make payments to the Registrar of Voters in accordance with Resolution No. 285928 for performing services on behalf of the City to conduct this election.

Section 9. The City Clerk is hereby directed to cause this ordinance to be published once in the official newspaper of The City of San Diego.

Section 10. Pursuant to Section 17 of the Charter of The City of San Diego, this ordinance shall take effect on the date of its adoption.
