
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to pay the sum of \$776,211.00 in settlement of the complaint against The City of San Diego, its agents and employees (Superior Court Case No. 449150, Diane Kay Sansted, et al. v. City of San Diego, et al.) resulting from the personal injuries alleged to have been sustained by Diane Kay Sansted, LaVerne Sansted and Marion Sansted on or about June 22, 1978, and any and all alleged losses sustained by Diane Kay Sansted, LaVerne Sansted and Marion Sansted as a result of said incident.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one warrant check in the amount of \$383,211.00 made payable to the "Executive Life Insurance Company" for the purchase of an annuity for Diane Kay Sansted, one warrant check in the amount of \$13,500.00 made payable to "LaVerne Sansted, Marion Sansted and their attorneys of record, Breidenbach, Swainston, Yokaitis and Crispo," and one warrant check in the amount of \$379,500.00 made payable to the "County Clerk in trust for Diane Kay Sansted, a minor," in full and final settlement of all claims and complaints.
