BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one warrant check in the amount of \$383,211.00 made payable to the "Executive Life Insurance Company" for the purchase of an annuity for Diane Kay Sansted, one warrant check in the amount of \$13,500.00 made payable to "LaVerne Sansted, Marion Sansted and their attorneys of record, Breidenbach, Swainston, Yokaitis and Crispo," and one warrant check in the amount of \$379,500.00 made payable to the "County Clerk in trust for Diane Kay Sansted, a minor," in full and final settlement of all claims and complaints.
