APPROVING MAP OF PARK VILLAGE ESTATES UNIT NO. 5

BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by Norbert Rudolph Hamelehle, a licensed land surveyor, entitled "PARK VILLAGE ESTATES UNIT NO. 5, being a subdivision of Lots 371 through 734 of Penasquitos Park View Estates, Unit NO. 3, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 10043, filed in the office of County Recorder of San Diego County, March 30, 1981, together with Pipilo Street, Vervain Street, Adolphia Street, Moran Way, Adolphia Court, Brome Way, Pipilo Court, Sedge Court, Melic Court and Kestrel Street, Salmon River Road and a portion of Black Mountain Road as dedicated to public use and Vervain Street as vacated and closed to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public portions of Vervain Street, and said portions of street are hereby declared to be portions of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the


easements with the right of ingress and egress for the construction and maintenance of drainage, sewer and water facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of a public street are accepted on behalf of the public as heretofore stated, and that the easements with the right of ingress and egress for the construction and maintenance of drainage, sewer and water facilities, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation of a portion of Vervain Street, approved by Council Resolution No. R-261629 on October 1, 1984, concurrently with the filing of the map.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
